SPAY/NEUTER ASSISTANCE PROGRAM: FIDO IS ONE OF A FEW LOCAL ANIMAL GROUPS WORKING TO REMOVE ALL BARRIERS TO SPAY/NEUTER BY SCHEDULING, TRANSPORTING, AND FUNDING SPAY/NEUTER SURGERIES ALONG WITH VACCINATIONS. MANY OF THE ANIMALS SERVED BY FIDO HAVE NEVER BEEN TO A VETERINARIAN AND HAVE REPRODUCED MULTIPLE PREVIOUS LITTERS, SOME ENDING UP IN OUR CITY SHELTER OR ON THE STREETS. FIDO REQUIRES COMPLIANCE WITH SPAY/NEUTER TO RECEIVE ALL SERVICES. IN 2024, FIDO ENSURED THAT 1,378 AT-RISK DOGS AND CATS WERE ALTERED.

FENCE PROGRAM: F.I.D.O. ASSISTS DOG OWNERS BY CONSTRUCTING OR REPAIRING FENCED ENCLOSURES TO FREE DOGS FROM CHAINS AND TO PROVIDE LARGE SECURE AREAS FOR DOGS TO EXERCISE FREELY. FENCED AREAS ARE BUILT TO ENCLOSE EXTERIOR DOORS OF THE HOME AND TO PROVIDE EASY ACCESS FOR OWNERS TO BRING THEIR DOGS INSIDE THEIR HOMES. F.I.D.O. IS THE ONLY ANIMAL WELFARE GROUP IN INDIANAPOLIS TO PROVIDE LARGE, SECURE, FENCED ENCLOSURES TO LOW-INCOME DOG OWNERS. THE PROGRAM PROVIDES A HUMANE ALTERNATIVE TO DOG TETHERING. F.I.D.O.'S FENCE PROGRAM ALSO PROMOTES PUBLIC SAFETY BY KEEPING DOGS SECURELY CONTAINED IN THEIR OWN YARD. F.I.D.O. COMPLETED 211 FENCE PROJECTS IN 2024 TO FREE OVER 500 DOGS FROM THE END OF A CHAIN.

PET FOOD PANTRY PROGRAM: F.I.D.O. PROVIDES APPROXIMATELY 15,000 POUNDS OF DOG AND CAT FOOD TO APPROXIMATELY 500 LOW-INCOME INDIANAPOLIS DOG/CAT OWNERS AND COMMUNITY CAT CARETAKERS EACH MONTH. F.I.D.O. ALSO ASSISTS LOW-INCOME DOG/CAT OWNERS AND COMMUNITY CAT CARETAKERS, BIWEEKLY, WITH THEIR BASIC PET SUPPLIES, INCLUDING FLEA TREATMENT, INSIDE DOG TRAINING CRATES, STRAW BEDDING, DOG HOUSES, COLLARS, AND LEASHES. IN 2024, F.I.D.O. DISTRIBUTED 172,066 POUNDS OF DOG AND CAT FOOD.

IACS DID PICK UP NOR TAKE IN STRAY DOGS UNLESS THEY WERE GRAVELY SICK OR INJURED OR EXTREMELY AGGRESSIVE. AS A RESULT, STRAY, ABANDONED, AND UNWANTED DOGS WERE LEFT TO RUN LOOSE ON THE STREETS OF INDIANAPOLIS. FURTHER, IACS SCHEDULED OWNER-SURRENDER APPOINTMENTS AS FAR IN THE FUTURE AS 4-5 MONTHS. AS A RESULT F.I.D.O. STAFF AND VOLUNTEERS FREQUENTLY FOUND STRAY AND ABANDONED DOGS. IN ADDITION, FIDO CLIENTS IN CRISIS, DUE TO SUCH FACTORS AS IMPENDING EVICTION AND JAIL, HAD NO ANIMAL SHELTER FOR THEIR DOGS WITH THE ONLY ALTERNATIVE TO TURN THEM LOOSE ON THE STREET. THEREFORE DURING THE LAST HALF OF 2024, F.I.D.O. TEMPORARILY HOUSED AND FOUND RESCUE FOR 66 DOGS THAT WOULD OTHERWISE BEEN LEFT TO ROAM THE STREETS.
